Executive Summary

Mountain Home Air Force Base (MHAFB) is pleased to announce the availability of the annual Drinking Water Consumer Confidence Report (CCR). The base water system produces high quality water and meets Environmental Protection Agency (EPA) standards to ensure all consumers receive safe drinking water. This report is a summary of water quality during the 2017 calendar year. Included are details about where your water comes from, what it contains, and how it compares to EPA and state standards. We are committed to providing you with information because informed citizens are our best allies.

Last year, we conducted more than 710 tests for over 83 contaminants. Of these, only one contaminant, nitrates, was detected above the Maximum Contaminant Level at well 9 in October 2017. Population served by this well (Air Traffic Control Tower) were previously advised in 2016 not to drink the water from this well and are supplied with bottled water for all drinking needs. In addition, well 4 was previously taken off line in 2016 when well 4 and well 9 were first found to have levels of PFOS/PFOA above the EPA Health Advisory level; well 9 does not provide drinking water. All other contaminants were either not detected or within EPA standards. III. POTENTIAL SOURCES OF CONTAMINATION:

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

A potential point source of contamination is any facility that stores, uses, or produces, as a product or by-product, regulated contaminants. For a potential point source to be included in the potential contaminant source inventory, it must also have a potential for release of contaminants at levels that could pose a concern relative to drinking water sources. It is important to understand that a release may never occur from a potential contamination source if best management practices are being used. Many potential sources of contamination are regulated at the Federal or State level, or both to reduce the risk of release. Therefore, when a business, military building, or property is identified as a potential contaminant source, this should not be interpreted to mean that this business, military building or property is in violation of any local, State, or Federal environmental law or regulation. What this means is that the potential for contamination exists due to the nature of the business, military building operation or type of activity on the property.

Sources that could potentially contaminate the drinking water supply for MHAFB include both point and non-point sources of contamination. Point sources of contamination occur at distinct locations. They are often regulated and require permits or registration for facilities that use, store or sell those materials (such as fueling stations with leaking underground storage tanks). Non-point sources of contamination often occur over large areas and can result from normal everyday activities such as lawn chemical or agricultural activities.

Potential Point Sources of Groundwater Contamination

The Idaho Department of Environmental Quality (IDEQ) has performed source water assessments on each of MHAFB's wells. All wells in the MHAFB well field are moderately susceptible to contamination from inorganic chemicals, synthetic organic chemicals, and microbes.

Potential Non-Point Sources of Groundwater Contamination

The general land use surrounding MHAFB is a combination of both agricultural and small business/residential. Non-point sources of contamination associated with these land uses are primarily agricultural chemicals including pesticides (insecticides and herbicides) and fertilizers. Additional potential non-point sources within the MHAFB Drinking Water/Wellhead Protection Zone include incorrect usage and disposal of Aqueous Film Forming Foam (AFFF), hazardous household chemicals such as cleaning solvents, used motor oil, and degreasers. Throughout the MHAFB Drinking Water/Wellhead Protection Zone, pesticides and small fuel storage cans used by military family housing may also pose threats to groundwater quality.

IV. COMPLIANCE VIOLATIONS

Treatment Techniques: None

Monitoring/Reporting: Two/Nitrate MCL Violation for Well 9 – occurred because the level of the completed sampling was higher than the MCL (maximum contaminant level).

Monitoring and reporting of compliance data violations

MHAFB received a violation in July 2017 for a water sample at Well 9 measuring nitrate levels at 11.1 ppm, which is above the nitrate MCL of 10 ppm. Additional sampling confirmed the exceedance. Well 9 is a stand-alone well that only provides water to personnel working in the Air Traffic Control Tower and does not affect the rest of the base population. Following the violation, bottled water was provided to personnel working in the Tower and a "Do Not Drink Order" was posted. Nitrate sampling is conducted quarterly due to historically high nitrate levels at Well 9. October samples measured our highest reading at 17.4 ppm.

Tower personnel will remain on bottled water due to Well 9's exceedance of PFOS/PFOA and nitrate standards.

Health Advisory for PFOS/PFOA

In August 2016, MHAFB sampled all wells at the source for PFOS/PFOA. Wells 4 and 9 both came back above the EPA Health Advisory of 70 ppt.

Well 9 is a stand-alone well that only provides water to personnel working in the Air Traffic Control Tower and does not affect the rest of the base population. Tower personnel were already issued bottled water due to the nitrate levels from Well 9; bottled water will continue to be issued to Tower personnel until a filtration system can be installed to control the PFOS/PFOA levels.

Well 4 results were 440 ppt; Well 4's water is blended with water from Wells 2 and 12 before entering the distribution system, reducing the at the tap levels to 105 ppt. MHAFB issued a Drinking Water Health Advisory as well as conducting 3 town hall meetings and providing bottled water to base personnel as an interim control while controls were evaluated. MHAFB leadership shut off Well 4, eliminating the source of the PFOS/PFOA. After Well 4 was shut OFF, sampling was performed and results showed that all locations were free of PFOS/PFOA, except one location, a Civil Engineering Mechanical room. The CE Mechanical room had a result of 19.6 ppt, which is well below the EPA Health Advisory. Following the results, MHAFB lifted the Drinking Water Health Advisory. As of 2017, MHAFB is currently evaluating options for a water treatment system to remove PFOS/PFOA from Well 4 in the future.

V. DEFINITIONS

Action Level (AL): The concentration of a contaminant, which, if exceeded, triggers treatment or other requirements, which a water system must follow.

Initial Distribution System Evaluation (IDSE): IDSE is an important part of the Stage 2 Disinfection By-Products Rule (DBPR). The IDSE is a one-time study conducted by some water systems, providing disinfection or chlorination, to identify distribution system locations with concentrations of total trihalomethanes (TTHMs) and haloacetic acids (HAAs). Water systems use results from the IDSE, in conjunction with Stage 1 DBPR compliance monitoring data, to select monitoring locations for Stage 2 DBPR. MHAFB completed the IDSE in calendar year 2012.

Environmental Protection Agency (EPA) Health Advisory: EPA has established health advisories for PFOS and PFOA based on the agency's assessment of the latest peer-reviewed science to provide drinking water system operators, and state, tribal and local officials who have the primary responsibility for overseeing these systems, with information on the health risks of these chemicals, so they can take the appropriate actions to protect their residents.

Maximum Contamination Level (MCL): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contamination Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL): The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

Treatment Technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

VI. HEALTH INFORMATION

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Your water is treated by disinfection. Disinfection involves the addition of chlorine or other disinfectant to kill dangerous bacteria and microorganisms that may be in the water. Disinfection is considered to be one of the major public health advances of the 20th century.

Contaminants that may be present in source water before treatment include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

Perfluorinated Compounds - Perfluorooctane Sulfanate (PFOS) and Perfluorooctanoic Acid (PFOA), which may come from a variety of sources such as firefighting foam, materials used to make carpets, clothing, fabrics for furniture, paper packaging for food and other materials (e.g., cookware) that are resistant to water, grease or stains.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.

Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

VII. Water Quality Data Tables

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of contaminants in water provided by public water systems. The table below lists all of the drinking water contaminants that we detected during the calendar year of this report. Although many more contaminants were tested, only those substances listed below were found in your water. All sources of drinking water contain some naturally occurring contaminants. At low levels, these substances are generally not harmful in our drinking water. Removing all contaminants would be extremely expensive, and in most cases, would not provide increased protection of public health. A few naturally occurring minerals may actually improve the taste of drinking water and have nutritional value at low levels. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. As such, some of our data, though representative, may be more than one year old. In this table you will find terms and abbreviations that might not be familiar to you. To help you better understand these terms, we have provided the definitions below the table.

Additional Information for Nitrate

Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant, you should ask for advice from your health care provider.

Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Mountain Home Air Force Base is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Water Conservation Tips

Did you know that the average U.S. household uses approximately 400 gallons of water per day or 100 gallons per person per day? Luckily, there are many low-cost and no-cost ways to conserve water. Small changes can make a big difference – try one today and soon it will become second nature.

- Take short showers a 5 minute shower uses 4 to 5 gallons of water compared to up to 50 gallons for a bath.
- Shut off water while brushing your teeth, washing your hair and shaving and save up to 500 gallons a month.
- Use a water-efficient showerhead. They're inexpensive, easy to install, and can save you up to 750 gallons a month.
- Run your clothes washer and dishwasher only when they are full. You can save up to 1,000 gallons a month.
- Water plants only when necessary.
- Fix leaky toilets and faucets. Faucet washers are inexpensive and take only a few minutes to replace. To check your toilet for a leak, place a few drops of food coloring in the tank and wait. If it seeps into the toilet bowl without flushing, you have a leak. Fixing it or replacing it with a new, more efficient model can save up to 1,000 gallons a month.
- Adjust sprinklers so only your lawn is watered. Apply water only as fast as the soil can absorb it and during the cooler parts of the day to reduce evaporation.
- Teach your kids about water conservation to ensure a future generation that uses water wisely. Make it a family effort to reduce next month's water bill!
